All concerned are hereby informed that applications are invited from the poor but meritorious students of our University Departments for the following types of benefits and scholarships for the session 2017- 18. Application forms may be downloaded from our university website (Dean of Students' Corner). Each application has to be recommended by the respective Head of the Department.

Last date of submission of duly filled in application to the Office of the Dean of Students is 10.09.2017

Free Studentship

Eligibility criteria

1. Family Income should not exceed Rs.4000/- per month (Family income certificate issued by BDO or any equivalent competent Group-A Govt. Officer or Secretary of Municipality etc is required to be produced along with application).

2. Minimum 65% marks or a GPA of 7.0 or above is required in the last qualifying or semester exam, as the case may be. Attested copy of mark sheet is required to be duly submitted along with the application form.

3. Only Tuition Fees will be waived and all other fees are required to be paid by the students as per the norms of the University.

Student Aid

Eligibility criteria

- 1. Only BPL/ANTODAYA card holder will be eligible for Student Aids. Original BPL/ANTODAYA card is required to be produced at the time of submission of form. A photocopy of BPL/ANTODAYA card duly attested by a Gazetted Officer/HOD/Academic Dean is required to be submitted along with the application.
- 2. Minimum 65% marks or a GPA of 7.0 or above is required in last qualifying or semester exam, as the case may be. Attested copy of mark sheet is required to be duly submitted along with the application form.
- 3. Aid of Rs. 1500/- per month for hostel students and 1000/- per month only for non-hostel students will be provided respectively.

Merit-cum-Means Scholarship

Eligibility criteria

- 1. Family income should not exceed Rs.8000/- per month (Family income certificate issued by BDO or any equivalent competent Group-A Govt. Officer or Municipal Secretary etc. is to be produced along with the Application Form).
- 2. Minimum 75% marks or a GPA of 7.5 or above in case of Humanities and 80% marks or 8.0 and above in case of Sciences is required in the last qualifying or semester examination, as the case may be. Attested copy of the mark sheet is required to be submitted along with the application form.
- 3. Minimum 75% of class attendance is mandatory
- 4. Payments will be made on quarterly basis to the eligible students.

Important points to be noted

- 1. No Student will be allowed to enjoy more than one financial benefit, either from the university or any Government Organizations or other agencies
- 2. All applications will be screened by the committee constituted by the Competent Authority
- 3. The benefit would be extended after obtaining prior approval of the Competent Authority
