## ANNEXURE-I

# **GENERAL TERMS AND CONDITIONS**

- (1) The successful bidder will be given Work Order on periodical basis in respect of publication of the University's advertisement in the leading newspapers as and when required. The matter to be advertised along with the names of the newspapers would be intimated along with the requisition.
- (2) The rates offered by the successful bidder will remain unchanged during the period of the Work Order. However, the benefit of downward rates, if any, is to be given to the University.
- (3) The rate to be offered should be all inclusive. However, GST as applicable will be extra. No other charges / taxes would be considered.
- (4) The University reserves the right to give a special Work Order to any other agency for any particular advertisement during the period of the Work Order.
- (5) The Work Order may be cancelled at any time before the expiry of its term due to nonsatisfactory performance of the agency or if it is felt necessary by the authority for the interest of the University.
- (6) Time is the essence of the work order. It is to be ensured that the matters will be published in the newspapers on the day as per the requirement of the University authority.
- (7) Tender without Tender Fee in proper form will be rejected
- (8) **Payment Terms:** No advance payment will be made. Payment will be made after completion of the satisfactory service and submission of tax invoice / bill along with the original pages of the newspapers containing the advertisements for which the bill is raised by the agency.
- (9) Income Tax, GST, and other taxes at the rates applicable from time to time as per the extant rules shall be deducted at the same source from the bill of the agency.
- (10) Acceptance of Tender: The Authority of PRESIDENCY UNIVERSITY, Kolkata does not bind itself to accept the lowest priced bid and reserves the right to reject any or the entire bids received without assigning any reason thereof.
- (11) **Incomplete and Conditional Bids** will be summarily rejected without assigning any reasons thereof.
- (12) **Period of Validity:** Bids shall remain valid for acceptance for a period of 90 days from the date of opening of the price bid.
- (13) The benefit of downward prices (revision on account of govt. financial policy, tax revision, etc.) should be given to PRESIDENCY UNIVERSITY, Kolkata by the selected bidder.
- (14) In case of any dispute, the decision of the University authority shall be final and binding on the bidders.
