All concerned are hereby informed that applications are invited from the poor but meritorious student of our University Departments for the following types of concession and scholarships for the session 2014-15.

# STUDENT AID:2014-2015 Procedure & Eligibility criteria:

- Applications are required to be submitted to the Dean of Students with the recommendation of the HOD.
- 2. Only BPL/ANTODAYA card holder will be eligible for Student Aids Original BPL/ ANTODAYA card is required to be produced at the time of submission of form. A photocopy of BPL/ANTODAYA card duly attested by a Gazetted Officer/ HOD/Academic Dean is required to be submitted along with the application.
- 3. Aid of Rs. 1500/- per month only for hostel students and 1000/- per month only for non-hostel will be provided respectively.
- 4. Minimum 65% marks or a GPA of 7.0 or above is required in last qualifying or semester exam, as the case may be. Attested copy of mark sheet is required to be duly submitted along with the application form.
- 5. No other financial benefit will be allowed for all those who are availing Poor Student Aid benefit.
- 6. All the applications will be screened by the committee formed by the Hon'ble Vice Chancellor.
- 7. Exceptional case if any, will be left to the discretion of Hon'ble Vice -Chancellors for his/her final approval.

The benefit of Poor Student Aid would be extended after obtaining prior approval of the Hon'ble Vice - Chancellor.

### FREE STUDENTSHIP 2014-2015

## Procedure & Eligibility criteria:

- 1. Applications (as per enclosed format) are required to be submitted to the Dean of Students with the recommendation of the HOD.
- 2. Family Income should not exceed Rs.4000/- per month (Family income certificate issued by BDO or any equivalent competent Group-A Govt.Officer or Secretary of Municipality etc is required to be produced along with application).
- 3. Only Tuition Fees will be waived and all other fees are required to be paid by the students as per the norms of the University.
- 4. No other student aid will be allowed for all those whose tuition fee is waived.
- 5. Minimum 65% marks or a GPA of 7.0 or above is required in the last qualifying or semester exam, as the case may be. Attested copy of mark sheet is required to be duly submitted along with the application form.
- 6. All the applications will be screened by the committee formed by the Hon'ble Vice-Chancellor.
- 7. Exceptional case, if any, will be left to the Hon'ble Vice- Chancellor for her/his approval.
- 8. The benefit of waiver of tuition fees would be extended after obtaining prior approval of the Hon'ble Vice Chancellor.

#### **MERIT CUM MEANS SCHLORSHIP:2014-2015**

### Procedure & Eligibility criteria:

- 1. Applications are required to be submitted to the Dean of Students with the recommendation of the HOD.
- 2. Family Income should not exceed Rs.8000/- per month (Family income certificate issued by BDO or any equivalent competent Group-A Govt.Officer or Secretary Municipality etc is to be produced along with the Application Form).
- 3. Minimum 75% marks or a GPA of 7.5 or above in case of Humanities and 80% marks or 8.0 and above in case of Sciences is required in the last qualifying or semester examination, as the case may be. Attested copy of the mark sheet is required to be submitted along with the application form.
- 4. Minimum 75% of class attendance is mandatory(A certificate of the same is required from the concerned HOD)
- 5. Payments will be made on quarterly basis to the eligible students.
- 6. No Student will be allowed to enjoy more than one financial benefit, either from University or any Government Organizations or other agencies.
- 7. All the applications will be screened by the committee formed by the Hon'ble Vice Chancellor.
- 8. Exceptional case, if any, will be left to the discretion of the Hon'ble Vice Chancellor for final decision.
- 9. The benefit of Means cum Merit scholarship would be extended after obtaining prior approval of the Hon'ble Vice-Chancellor.
